What Data Do We Collect?

We collect the following information from you via the Website and Platform:

- Your name and e-mail address
- Information you provide when sending inquiries and/or requests for support
- Photographs and videos you as a grantee upload
- Grant reporting data provided by you as a grantee
- Grant data provided by funders subscribing to Foundgood

How Do We Collect Your Data?

You directly provide Foundgood with most of the data we collect. We collect data and process data when you:

- Register online or request to use our products or services.
- Voluntarily complete a customer survey or provide feedback via email
- Use or view our website via your browser's cookies.
- Upload text, photos, videos to describe initiatives and their progress

Foundgood may also receive data directly from the funders of grants and hence we have a data handler agreement in place for each of such funders.

How Will We Use Your Data?

Foundgood collects your data so that we can:

- Administer the Website and Platform and perform internal operations including providing login details, troubleshooting, data analysis, testing, research, statistical and survey purposes
- Provide you with information in respect of the Website and/or Platform
- Provide you with any support that you may request in relation to the use of the Website and/or Platform
- Ensure that features and content from the Website and Platform are available for you (if you choose to use them) and are presented in the most effective manner for you and for your devices
- Check and confirm that we carry out your instructions accurately, to enable us to review and improve our services and operations and develop new and changed, services and operations
- Keep the Website and Platform safe and secure
- Contact you if you have chosen to subscribe to our mailing list to receive updates from us

Use of Artificial Intelligence

As part of our internal operations, we use artificial intelligence (AI) services in a secure, private environment provided by **Amazon Bedrock (AWS)**. These services support data processing, content generation, and analysis related to the use of our platform.

We ensure the following:

- **Data privacy by design**: Prompts and outputs processed through the AI are not stored by Amazon Bedrock and are not used to train any models. No data is shared with third parties or used for marketing or profiling.
- **User-specific access**: Any outputs generated from AI are accessible only to the specific user who provided the input.
- **No personal data training**: We do not use personal data to train or fine-tune AI models.
- **Lawful basis**: We rely on legitimate interest as the legal basis for processing this data, limited strictly to the purposes of improving user experience and supporting platform functionality. Where required, we may also ask for your consent.
- **Data minimization and purpose limitation**: Only data necessary for specific, defined purposes is processed, and never beyond the original intent.
- Security and confidentiality: All Al processing takes place within our secure infrastructure. Data is encrypted in transit and at rest. We use Amazon Web Services

(AWS) located in the EU, and manage encryption keys through AWS Key Management Service (KMS).

• **Transparency and accountability**: We maintain internal logs of AI usage via AWS CloudWatch and CloudTrail to monitor compliance and security.

This use of AI complies with the EU General Data Protection Regulation (GDPR), particularly Articles 5 (principles), 6 (lawful basis), 25 (data protection by design), and 32 (security of processing).

How Do We Store Your Data?

Foundgood securely stores your data at Amazon Web Services, EU and Salesforce Imtd., UK.

Foundgood will keep grant data for as long as required by the granting foundation. As a grantee, please contact your funding organization to understand how long time this is as it may vary from funder to funder. Once this time has expired, we will delete your data.

Please note that personal data can be held in a non-anonymised form for a period of up to 12 months following closure of your account/erase of your personal data as part of our regular system backup schedule.

What Are Your Data Protection Rights?

Foundgood would like to make sure you are fully aware of all your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request Foundgood for copies of your personal data. You can be charged a small fee for this service.

The right to rectification – You have the right to request that Foundgood correct any information you believe is inaccurate. You also have the right to request Foundgood to complete the information you believe is incomplete.

The right to erasure – You have the right to request that Foundgood erase your personal data. You can be charged a small fee for this service.

The right to restrict processing – You have the right to request that Foundgood restrict the processing of your personal data.

The right to object to processing – You have the right to object to Foundgood's processing of your personal data

The right to data portability – You have the right to request that Foundgood transfer the data that we have collected to another organization, or directly to you. You can be charged a small fee for this service.
